



#### **Design Process**

OJB is first and foremost a design firm. During site visits, we pay close attention to the environmental clues that reveal the opportunities and constraints that will inform our design work. 



CBG Strategies developed the Absent but Counted campaign on behalf of the Montgomery County Circuit Clerk with the goal of safely and effectively educating Montgomery County voters to apply for, cast and track their absentee ballots. The campaign resulted in a 400% increase in absentee voter ballots (the state had a 278% increase).

CBG Strategies developed a community engagement campaign, the Protect Alabama Campaign for the Alabama Department of Health to educate minority populations on the effectiveness of the COVID-19 vaccines and to minimize disparity in vaccine adoption and distribution. Their team deployed a layered communication strategy that involved digital outreach, coalition building, direct mail and direct resident engagement. The campaign resulted in more than 50,000 doors canvassed statewide, engagement of Five HBCUs, and a statistically synonymous vaccination coverage rates between minority and non-minority community in Alabama.

Finally, CBG Strategies led the Randall Woodfin for Mayor of Birmingham Re-Election Campaign: Progress Together. In Birmingham's most recent election cycle, the team was instrumental in the re-election campaign of Randall Woodfin for Mayor. Through the design and execution of direct mail and local ads, they were able to ensure that the campaign's platform and objectives were effectively communicated with voters. As a result, the Woodfin campaign was able to expand its scope beyond likely voters and, on election night, received 64% of the vote.
